



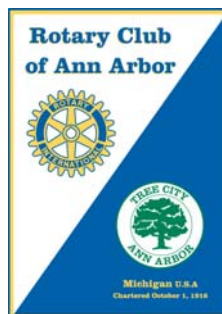

ANN ARBOR ROTARY ENDOWMENT – PLANNED GIVING INFORMATION:

One way for club members to help Ann Arbor Rotary achieve its goal of \$100,000 annual Endowment distributions to fund the Club’s international and local service projects, college scholarships and other youth-focused programs is with a *planned gift* to the Endowment to take effect at your death. You may include such a gift in a new will or trust, a codicil to an existing will or amendment to an existing trust agreement, or by beneficiary designation for a retirement plan or life insurance policy death benefit. You can make either an outright gift of a specified sum of money, real or personal property, or a percentage of your probate or trust estate or retirement plan or insurance death benefit; a residuary bequest leaving all or a designated portion of what remains of your estate after payment of debts, taxes, expenses and other bequests; or a contingent bequest that will take effect if other named beneficiaries do not survive you. You are encouraged to consult your attorney and/or tax adviser about any such arrangement, but here is sample language for two of these forms of planned giving:

Specific Bequest: *I give to the Ann Arbor Rotary Endowment, a Michigan nonprofit corporation,*

- (a) The sum of _____ Dollars (\$_____), OR*
- (b) A portion of my estate totaling ___ percent (___%) thereof, OR*
- (c) The following described real estate or personal property _____*

to be held in the Endowment’s Permanent Fund and used and disposed of in accordance with its stated purposes as its Trustees shall direct.

Residual Bequest: *All (or ___%) of the residue of my estate of whatever kind and wherever situated which I own or have the right to dispose of at the time of my death I give to the Ann Arbor Rotary Endowment, a Michigan nonprofit corporation, to be held in the Endowment’s Permanent Fund and used and disposed of in accordance with its stated purposes as its Trustees shall direct.*

Statement of Planned Gift Intention
